#### **Entrants:**

To redeem the offer, entrants must have a smart phone and order in-restaurant via mobile QR code at any one of The Pancake Parlour's 12 Melbourne locations.

# **Entry Restrictions:**

Must be aged 13 years + (entrants under the age of 13 yrs must have parental consent).

#### **Promotion Period:**

Starts: 9:01am AEDST 16/12/2022 Ends: 11:59pm AEDST 28/02/2023

# **Summer Parlour promotion**

Each week, The Pancake Parlour will announce a new choice from their menu, which will be available to all customers – members and non-members - for \$5 when the temperature reaches 30C. The offer will be available for dine in via mobile ordering only. See *Location of offer redemption* for more details.

### **Location of Entry**

Customers can simply redeem the weekly Summer Parlour treat when the temperature hits 30C at any of The Pancake Parlour's 12 open Melbourne restaurants. This does not include the Ballarat location (licensee).

## **Temperature announcement**

The Pancake Parlour Head Office will communicate via their social media channels and send a push notification to app user informing them when they can redeem their treat once the temperature hits 30 degrees Celsius according to the Bureau of Meteorology (BOM) official application set in the

'Melbourne Airport' location. Customers can keep track of the live temperature via www.summerparlour.com.au.

## **Details of Summer Parlour weekly offer**

On Friday of each week during the promotional period, customers will be advised of a new choice via email communication and push notification, as well as The Pancake Parlour Facebook, Instagram and TikTok networks. The weekly offer will be valid until 11.59pm on the Thursday of the following week – active only when the temperature hits 30C – for that day only.

#### **Activation of offer**

The Summer Parlour offer becomes active when the temperature reaches 30C at the 'Melbourne Airport' location according to the BOM, which is indicated on the Summer Parlour website (<a href="www.summerparlour.com.au">www.summerparlour.com.au</a>). It may take from 30 minutes to an hour for the offer to be announced via The Pancake Parlour app, Facebook and Instagram networks.

# Location of offer redemption

Summer Parlour offers can be redeemed at ANY Melbourne The Pancake Parlour restaurant by scanning the QR code to access the mobile ordering platform and heading to the 'Promotions' tab. There is no restriction to which restaurant the offer can be redeemed from. The Ballarat location is not included in this promotion.

#### **Maximum Number of entries:**

Customers can redeem the \$5 offer as many times as they wish once the temperature hits 30C, however only until 11.59pm the night the offer becomes active.

## Other offers during promotional period

Customers will be able to redeem all other offers including member offers in conjunction with the Summer Parlour offer, unless specified in the Terms and Conditions of this promotion. This includes redemption of any reward from the Lovely Rewards program.
